Whereas **JONATHAN KITTRELL** hath this day complained to me on oath that John Davis and **DUNCAN CAMPBELL** are just lie indebted to **POMFRET HERNDON** and **JONATHAN KITTRELL JR.** administrator of **WILLIAM BRYAN**, deceased, of the just sum of £70, 9 Shillings and Sixpence, due by bond bearing date the 8th day of March 1774 with the penalty of £40, 19 Shillings with interest from the 8th day of January 1775.

While paid these are therefore to command you that you attach the property of said **JOHN DAVIS & DUNCAN CAMPBELL**, or so much thereof repleviabie on security as shall be sufficient to satisfy said debt and cost and the same to keep so that you have them before the justices aforesaid court on the first Monday of May next then and there to be subject to the necessary proceedings to be had thereon, to satisfy the aforesaid debt and costs.

Herein fail not and have you then and there this writ.

The foregoing attachment was returned to make Court 1788, levied in the hands of **CHARLES R. EATON** Esquire and him summoned as garnisher. **JOHN YOUNG** sheriff.

And at the aforesaid term to wit: May term 1788 the garnisher appeared and declared that he had enough in his hands to satisfy the debt and costs judgment according to specialty £35.15 & costs.
