This is to certify that **BENJAMIN BRIANT** has steadfastly done his duty since the passing an Act at Augusta to wit:

The 20th of August 1787 until the total expulsion of the British from this state & that he can not, to my knowledge or belief, be convicted of plundering or distressing the said county and is therefore, under said act, entitled to a bounty of 2,877 acres of land.

Given under my hand this 26th of July 1784.

To **JOHN RAGAN**, Esqr., County Surveyor

You are hereby authorized and required to admeasure and lay out unto **BENJAMIN BRIANT** a tract of land containing three hundred & fifty acres in said county of Hancock on his own head-rights.

Taking especial care that the same hath not been heretofore laid out to any person or persons. And you are hereby also directed and required to record the plat of the same in your office and transmit a copy thereof together with this warrant to the Surveyor General within two years from the date hereof.

Given under our hands this 2nd day of January 1797.
