Beginning at a Pine; running thence N60W 80 poles to a Hickory in **JAMES CAMPBELL**'s line; then with his line S6E 174 poles to a Hickory; then nearly with **ALEXANDER**'s line N48E 93 poles to a stake 20 poles south from a corner Pine; then N 160 poles to the beginning.

TOGETHER with all and singular the rights, members, hereditaments, and appurtenances to said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said **JAMES BRYAN**, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said **JAMES BRYAN**, his heirs and assigns, against myself and my heirs, against every other person or persons whomsoever claiming or to claim the same or any part thereof.
