The condition of this obligation as such, that if the above bounden **ISABELLA BARNHILL** and **ROBERT HEMPHILL,** administrators of the goods, chattels, and credits of **WILLIAM BARNHILL,** deceased, to make or cause to be made a true and perfect inventory of all and singular that goods, chattels, and credit of the said deceased, which have or shall come to the hands, or possession, or knowledge of the said **ISABELLA BARNHILL** and **ROBERT HEMPHILL,** administrators, or into the hands or possession of any other person's for them and the same do be made do exhibit unto the said Court of ordinary, for York District, at such time as they shall be there unto required by the said court, and the same goods, chattels, and credits, do well and truly administer according to law, and make a just and true account of their acting's and doings, when by law required, then this obligation to be void, or else to remain in full force.
