I GIVE demise and bequeath to him and his heirs all and every my messuages, lands, tenements, and hereditaments whatsoever and wheresoever which. I also charge with the payment of my said debts.

In witness whereof I have hereunto set my hand and seal the 22nd day of February and in the year of Our Lord 1796.
