IMPRIMIS I give and bequeath to my loving son **ARTHUR HAZZARD** one negro boy named ISAAC to him and his heirs and assigns forever.

SECONDLY I give and bequeath to my grandson **THOMAS HAZZARD** my best bed and furniture, namely one rug and blanket, two pillows and cases, two pairs of sheets, one sow and pigs, one cow and calf, and two young steers to him and his heirs and assigns forever.

THIRDLY I give and bequeath onto my five daughters, **ELIZABETH STOCKLEY**, **HESTER ROBINSON**, **SARAH WEST**, **ANN MILBY**, and **COMFORT CRAIG** my wearing apparel to be equally divided among them mm are heirs and assigns forever.

FOURTHLY I give and bequeath to my loving daughter **COMFORT CRAIG** my silver teaspoons and a half part of my table linen and towels. The other half of my table linen and towels to my daughter **ANN MILBY** and a spinning wheel to each of them, their heirs and assigns forever.

FIFTHLY I give and bequeath to my grandson **DAVID CRAIG** one cow and calf to him and his heirs and assigns forever.

SIXTHLY I give and bequeath to my two granddaughters **ANN HAZZARD** and **SARAH HAZZARD** daughters of **ARTHUR HAZZARD** all my computer to be equally divided between them their heirs and assigns forever.

SEVENTHLY I give to my granddaughter **SARAH HAZZARD** daughter of **JOSEPH HAZZARD** 1 spinner wheel XXX to her and her heirs and assigns forever.

EIGHTHLY I give to my daughters **SARAH WEST**, **ANN MILBY** and **COMFORT CRAIG** all my negroes except the boy before given to my son **ARTHUR** to be equally divided between them their heirs and assigns forever.

NINETHLY and lastly I give and bequeath to my son **ARTHUR HAZZARD** all the rest and residue of my estate both real and personal to him, his heirs and assigns forever.

And I do hereby constitute and appoint my loving son **ARTHUR HAZZARD** whole and sole executor of this my last will and testament, utterly revoking and disannulling all other and former Wills find me heretofore made ratifying and confirming this have no other to be my last will and testament this 25th day of May 1780.
