And as for what estate it has pleased God to bless me with and this life I give and bequeath it in the matter and form following being in perfect senses that is to say:

IMPRIMIS I give unto my well-beloved wife **BETTY HILL** all my whole and sole estate both real and personal during her life allowing her to be whole and sole executrix.

ITEM after the decease of my wife, **BETTY HILL**, I will my estate to be equally divided between my two daughters viz, **COMFORT SHAW** and **NANNY BRIAN** in a quiet and Peaceable manner.

THIRDLY and lastly I constitute an ordained this to be my last will and testament disannulling all others heretofore by me made.

As witness my hands this 8th day of January in the year of Our Lord 1778.
