ITEM I give and bequeath to my loving daughter **MARTHA** [**DEW**] do all my estate that fell to me by my father **ABRAHAM DEW**, deceased, and also one cow and calf and her increased her her and her heirs forever.

ITEM I give and bequeath to my loving brother **WILLIAM DEW** one striped cotton gown to him and his heirs forever.

ITEM I give and bequeath to my loving sister **SALLY [DEW] ROGERS** three white linen caps, two pair of woolen stockings, one pair of cotton stockings to her and her heirs is forever.

ITEM I give and bequeath to my loving daughter **MARTHA [DEW]** do all the remainder of my wearing apparel to her and her heirs forever.

And I do desire that **THOMAS VIVERET**, my present guardian at this time, whom I make sole executor of this my last will and testament, may take care of my daughter **MARTHA** and to be appointed guardian for her.
