I **ROBERT ROBISON** being weak of body but of perfect binding memory calling to mind the mortality and approaching dissolution of my body knowing that it is appointed unto all men once to die, do make and ordain this to be my last will and testament and -

FIRST I do recommend my soul into the hands of almighty God that gave it and my body to the earth to be buried in a Christian decent manner at the discretion of my executor.

And as touching such worldly Goods as it has pleased the lord to bless me with in this life I dispose of them in the following manner and form.

In the first place it is my will and pleasure that all my just and lawful debts be paid and all the residue and remainder of my property to be equally divided amongst all my children now live.

And lastly I hereby nominate, constitute, and appoint **ROBERT ROBISON**, son to my brother **WILLIAM ROBISON**, and **ROBERT ROBISON**, son to my brother **DAVID ROBISON** to be my whole and sole executors of this my last will and testament, and I do hereby disannul all former wills, legacies, or bequests by me heretofore mentioned, ratifying this and no other to be my last will and testament.

In witness whereof I have hereunto set my hand and seal this 5th day of July 1797.
