Know all people, that I **MARGARET LAMBETH** of York district and state of South Carolina, now far advanced in age yet through the mercy of almighty God enjoying reasonable bodily health and the proper use of my mental powers, and knowing that mortality of all mankind, do by these presents ordain this, my last will and testament, committing myself, with all my mental and bodily Powers into this tender care and as for the worldly Goods, God and His benign Providence have bestowed on me, I do hereby disposed of in the following manner, viz.

First I will that all my just debts be paid.

Secondly I give him bequeath to my son **JOHN K. BENSON** one third part of my wearing apparel, also of my bed clothing, and one feather bed, and five dollars in cash.

Thirdly I give and bequeath to my son **GEORGE B. DUFF** all and singular the balance of my estate, both real and personal. Lastly I do hereby nominate appoint my son, **GEORGE B. DUFF**, executor of this my last will and testament, revoking and disannulling all others but this, and this only.
