In the name of God Amen.

I **SOLOMON A. KITTRELL** of Clarksville in the state of Tennessee, being very sick and weak and body but of sound mind, and considering the uncertainty of life to make and publish this my last will and testament in manor following, to wit:

I desire that all my town property in Clarksville lately bought of **SAMUEL VANCE**, and such perishable property medicine & c. as my executors may deem necessary, may be sold by my executors as soon as may be convenient after my deceased.

Also all my debts, owing me, collected, and the monies are rising after paying all my debts to be disposed of by my executors for the benefit of my wife and children.

And all my other property, including Negroes, I desire may be left in the hands of my executors for the maintenance of my wife and children until they or either of them marry or come of age, when each one is to have his or her share, each and equal proportion.

And in case my said executors think it necessary, and for the benefit of my family, it is my desire that a small tract of land may be purchased for the benefit of my wife and children whereon she may reside and raise my children.

And I hereby constitute and appoint my father-in-law, Doctor **JOHN BRODIE**, and my brother-in-law, **THOMAS BRODIE**, to be the executors of this, my last will, hereby revoking all others and declaring this and no other to be my last will and testament.

We the undersigned Commissioners appointed by the county court of Montgomery by order of January term 1824 have divided the Negroes of the estate of **SOLOMON A. KITTRELL**, deceased, this 9th day of February 18-24 in the following manner:

To **ANN T. HARRISON**, late **ANN T. KITTRELL**, the following Negroes: **WARREN**, **SAM**, **MIMA** & child, **JACKSON**, **CHERRY** and **SEATHY** amounting to \$2,475 and also \$75 in Tennessee money.

**MARY KITTRELL** Negroes: **HENRY**, **JIM**, **LUCY**, and child normal **NORVAL**, **POLLY**, **NANCY** and **CRESY** amounting to \$2,325 also \$225 in Tennessee money.

**MARTHA KITTRELL** Negroes: **CASEY**, **PATRICK**, **LUCKY** and **PIM** her child, **DANIEL**, **HENRY** and **PATSY** amounting to \$2,550.

KNOW ALL MEN BY THESE PRESENTS that we, **JOHN BRODIE, FRANCIS BAKER** and **EDWIN D. KILLEBREW**, are held and firmly found unto **CHARLES BAILEY, SAMUEL SMITH** and **WILLIAM R. GIBSON**, justices of the county court of Montgomery, their successor or successors, survivor or survivors, their executors, administrators or assigns in the sum of \$4,000 for the benefit of **MARY [KITTRELL]** and **MARTHA KITTRELL** for the payment of which we bind ourselves, our heirs, executors, administrators and assigns, jointly and severally, firmly by these presents sealed with our seals and dated this 18th day of April 1825.

THE CONDITION OF THE ABOVE OBLIGATION is such that whereas **JOHN BRODIE** has been appointed guardian to the said of **MARY [KITTRELL]** and **MARTHA KITTRELL** now of the said **JOHN BRODIE** shall well and faithfully make true returns, and settlements make with the county court of Montgomery agreeable to law during his said guardianship and at the expiration thereof, shall, will, and faithfully account with the said justices of the county court of Montgomery, and pay over to them or their order, the profits of said **MARY** and **MARTHA** that may come into his hands, by virtue of said guardianship, together with the profits and the said **JOHN BRODIE** as aforesaid shall demain himself in all things relative to said guardianship agreeable to court and then this obligation to be void, else to remain in full force and virtue in law.
