He enlisted, while residing in York District, under Lt. John Brannon and Col. Thomas Neel. In June 1780, he was a lieutenant under Capt. Jamison and Col. Locke and served in a North Carolina unit. He then joined Gen. Sumter and was in Huck's Defeat, the battles at Rocky Mount and Hanging Rock, where he was wounded in the shoulder by a musket ball. After being released from the hospital, he rejoined Capt. Jamison as a private and was in the battle at Cowpens. He also served at one time under Capt. Barnett as a spy. Later, in 1781, he joined Gen. Sumter as a spy. Next, he was under Capt. Moffett and Gen. Greene. He was in the battles at Biggin Church and Wappoo Bridge. At sometime, probably late 1781 and early 1782, he was under Capt. Edward Martin and Col. Winn. A.A.6531; O158; S20.

First, he served in a North Carolina unit. Then, he moved to Spartanburg District and served under Capt. Prince and Col. Pickens. He was also under Capt. William Smith and Col. Hammond. Thereafter, he was under Capt. Wofford and Maj. Ford. He was in the engagement at Fort Galphin and the siege of Ninety Six. In 1781, he was commissioned captain and served under his brother, Col. Benjamin Roebuck. A.A.6532; X3692.

**Robuck, John**

b. 1759/60, Culpeper County, Va.

He enlisted during 1778, while residing in Spartanburg District, under Capt. John Thomas. He was in several engagements with Tories and in the battle at Bush River under Col. Williams. He also served under Col. Benjamin Roebuck, his brother. Early in 1779, he joined Capt.

Culbertson who was replaced by Capt. William Smith. This company joined Gen. Sumter and was in the battle at Blackstock's Plantation. Capt. Edward Michison replaced Capt. Smith and Michison was replaced by Capt. George Robuck. He was commissioned captain under Col. White. His headquarters was on the farm of Ebenezer Moss on Two Mile Creek (Spartanburg). At sometime, he was under General Pickens. (Moved to Ala.) A.A.6554; S662; T662; X3693.

**Rochas, Jean Francis De La Tour**

He served in the First Regiment. N.A.853.

**Rochateer, Robert**

He served in the militia after the fall of Charleston. A.A.6534; S27.

**Roché, James**

He was at the fall of Charleston. He served thirty days as a private and ninety days as a lieutenant in the cavalry under Colonel Peter Horry during 1782. A.A.3767; A.A.6536; A.A.6537; Q70; Yearbook, 1897.

**Roché, Patrick**

He served as an ensign in the militia during 1775. Heitman, p. 471.

**Roché, Thomas**

He enlisted during August 1775 in the Charleston Volunteer Militia under Captain Charles Drayton. S.C.H.&G., I, 187.

He served seventy-six days in the militia during 1779. Y162.
