York District) in the name of God , Amen. I Elizabeth Patterson
of the District aforesaid being of sound & disposing mind &
memory, do make this my last will& Testament in manner &
form following

Item 1st I give & bequeath to nieces Jane E & Margaret E & my
nephew James L. Children of my deceased brother William M. Bigger
the sum of three hundred dollars to be equally divided amongst
them

Item 2nd I give & bequeath to my nephew & nieces James, John,
Martha & Amelia Neagle children of my deceased sister Mary Ann
Neagle, the sum of three hundred dollars to be equally
divided amongst them

Item 3rd I give & bequeath one feather bed to my niece Margaret
E. Bigger

Item 4th I will & direct that my plantation on Allison creek be
sold, and the proceeds of sale be equally divided between
Alexander B. Bigger, Moses A. Bigger, Ann E. Bigger & Martha E.
McClean.

Item 5th I give & bequeath to my niece Ann E. Bigger my negro
boy Lark, and I also give to her my interest in the Suggy &
harness now owned by her & myself jointly.

Item 6th I give & bequeath to my niece Martha E. McClean my negro
woman Minny.

Item 7th I give & bequeath to my nephews & nieces Alexander B.
Bigger, Moses A. Bigger, Ann, E. Bigger & Martha E. McClean, all my
negroes not herein before disposed of to be equally divided
between them. I mean by an equal division of said negroes, that
each of my said nephews & nieces is to have an equal share in

value of the negroes.

And if it so happen^d that one or more of them get in the negroes allotted to them more than his or her share ,he or she to account in money to him or her whose share is less valuable. The division of the negroes to be made by said nephews& nieces if they agree otherwise by three disinterested persons selected by them.

Item 8th I direct my barouche & harness to be sold & the proceeds to be equally divided between Alexander B.Sigger, Moses A.Bigger, Ann E Bigger,& Martha E.McLean

Item 9th I give & bequeath to Alexander B Bigger, Moses A. Bigger, AnnE.Bigger& Martha McLean my household & Kitchen furniture my horses & cows and the balance of my property of what soever kind and I also give to them all the money I may have on hand at the time of my death, all debts that may be due & owing to me & allthe rest & residue of my estate--- but my meaning is that the specific legacies mentioned in the first & second clauses of this my will are to be paid before s said balance & residue of my property & Estate are divided.

Item 10th I hereby revoke all former wills by me made and nominate & appoint G W.Williams, executor of this my last will & Testament. In testimony whereof I have hereunto set my hand& seal this the sixth day of June in the year of our Lord one thousand eight hundred and fifty three
