His excellency **ARTHUR DOBBS**, Esq., Captain-General, Governor and Commander in Chief, in and over the said province.

To the Surveyor-General, Greeting,

You are forthwith to admeasure and lay out, or cause to be admeasured and laid out unto **LEWIS FRANKLIN BRYANT** a Plantation, containing two hundred acres of land, in the county of Dobbs on the south side of Neuse River near the westernmost prong of Falling Creek called Back Swamp, bounding on his own line or **ARTHUR FORT'S** former land and joining **JOSEPH PIPKIN** and **WILLIAM CRAWFORD'S** lines.

Observing his Majesty's instructions for running out lands; two just and fair plans whereof, with a proper certificate annexed to each, you are to return into the Secretary's office, within twelve months from the date hereof: And if the warrantee shall not within eighteen months from the date hereof, take out a patent for the said land, this warrant, and all proceedings thereon, shall be void and of no force; and the said land shall be deemed vacant and free to be taken up by any other person.

Given at Wilmington under my hand, the fifteenth day of April Anno Domini 1763.

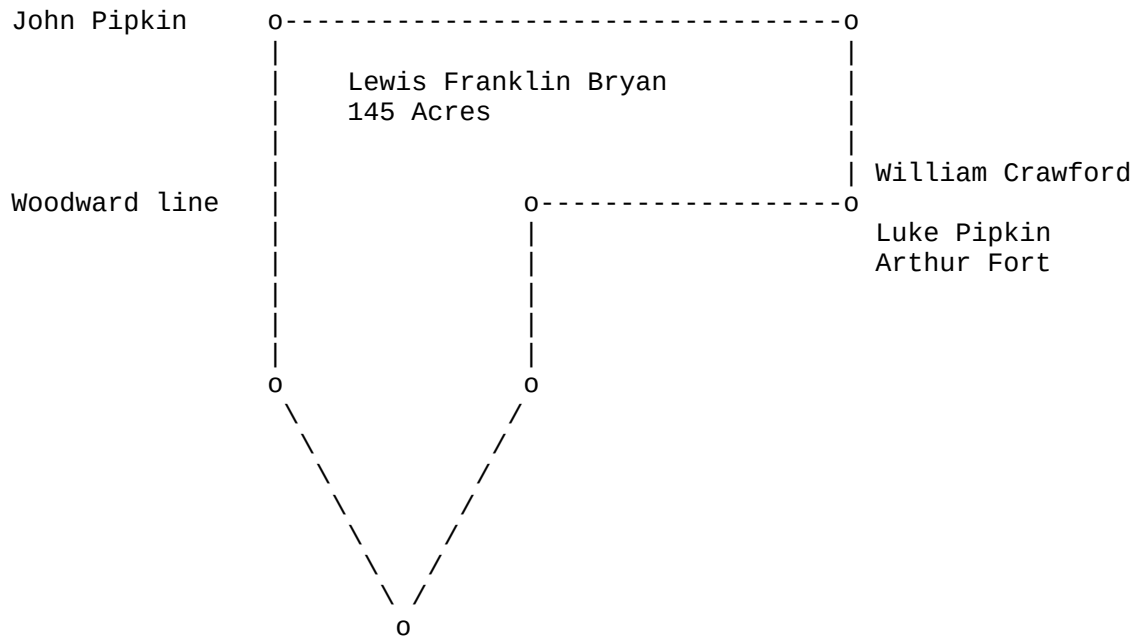

Surveyed for Mr. **LEWIS FRANKLIN BRYANT** one hundred & forty five acres of land in the county of Dobbs, lying on the south side of Neuse River near the westernmost prong of Falling Creek.

Beginning at a Black oak, the dividing corner between **WILLIAM CRAFFORD [CRAWFORD]** & **LUKE PIPKIN** in **ARTHUR FORT**'s former Line; thence running along said line S 65 E 70 poles to a Pine, **JOHN PIPKIN**'s corner of said land; thence with his N 25 E 320 poles to his corner Red Oak on the swamp side; thence along **WOODARD**'s line S 7 E 420 poles to a Pine; thence N 65 W 215 poles to a White Oak; thence N 14 E 77 poles to the first station.
