

**Deed, NC, Union, WILLIAM BRYANT to THOMAS WOODSON, 1802**

The state of South Carolina

KNOW ALL MEN by these presents that we, **WILLIAM BRYON** and **HANNAH BRYON**, of Union district and state aforesaid for and in consideration of the sum of \$300 to us in hand paid by **THOMAS WOODSON** of the state and District aforesaid have granted, bargained, sold, and released and by these presents to grant, bargain, sell, and release unto the said **THOMAS WOODSON** all that Plantation or tract of land containing 100 acres, be the same more or less, lying and being in the state and District aforesaid and joining the lands now claimed by **JESSE HOWARD** on Sugar Creek also **GEORGE [HARLIN] HARLAN's**, **JOHN CURTIS**, **THOMAS PALMER** and **WILLIAM PALMER**, it being part of a tract of land laid out for **PHILLIP BRYON Sr.**, deceased, containing 200 Acres. The above described 100 acres being part thereof.

TOGETHER WITH ALL and singular the rights, members, hereditaments and appurtenances to the same premises belonging or in anywise incident or appertaining.

TO HAVE TO HOLD all and singular the premises before mentioned unto the said **THOMAS WOODSON**, his heirs and assigns forever,

AND WE do hereby bind ourselves, our heirs, executors, and administrators to warrant and forever defend all and singular the same premises unto the said **THOMAS WOODSON**, his heirs and assigns, against ourselves, our heirs, and against every other person or person whomsoever lawfully claiming or to claim the same or any part thereof.

WITNESS OUR HANDS and seals this 30th day of December in the year of Our Lord 1802 and in the 27th year of American independence.
