Know all men by these presents that I **NATHAN FRINK** of Prince George Parish Craven County and province aforesaid Planter for and in Consideration of the sum of Three hundred Pounds Current money of this Province to me in hand paid the receipt whereof I do hereby acknowledge have bargained sold Sett over and delivered and by these presents do bargain sell sett over and deliver unto **WILLIAM GAUS** on Long Bay parish County and Province aforesaid Innkeeper Three Negroes (Viz) CESAR, MARCH, and HANNAH to Have and to hold the said bargained premises unto the said **WILLIAM GAUS** and his Heirs forever and to the only proper use and behoof of him and his aforesaid and I the said **NATHAN FRINK** for myself, my Heirs Executors Administrators or Assigns shall and will forever defend by these presents.

Know all men by these presents That I **NATHAN FRINK** of Prince Georges Pariah Craven County and Province aforesaid Planter for and in Consideration of the sum of Three hundred rounds Current money of this Province, the Receipt whereof I do hereby acknowledge and is there with fully Content & Satisfied, have bargained, sold, sett over, and delivered and by these presents do bargain, sett over and deliver unto **WILLIAM GAUS** on Long Bay Parish County and province aforesaid, inn keeper, all and whole my stock of cattle on Wacama and Little River marked in the right ear with 3 crop and slit in the Left ear with 5 nick, branded [see original] thus, likewise Sheep and Eight Geese and an old Canoe and Sundry Household furniture Plantation Tools and Sundry other things as pr. an inventory hereto annexed doth more plainly appear, to Have and to hold the said bargained premises unto the said **WILLIAM GAUS** and his Heirs forever to the only proper use and behoof of him and his aforesaid and I the said **NATHAN FRINK** for myself, my Heirs, Executors, administrators or assigns shall and will Warrant and defend against the claims of all persons whatsoever.

A Desk with Drawers, a Large Mahogany table, a small tea Table, 2 small Tables, 2 Cheats, 3 Bedsteads a Couch and 2 feather Beds, 3 iron pots, & one tea Kettle, a pair Mill stones, a parcel of case and quart bottle, 4 some old chairs, a parcel axes and hoes, 2 grind Stones, pewter, Some corn at Little River, a parcel Lumber up Hairs, some raw hides, some tanned Leather, a whip, crosscut saw, pails piggins & Kellers & other Lumber, 2 Trivets, 2 pot rakes, 2 fluke ploughs, a wire sieve, some carpenters Tools, coopers Tools (Viz) an adz, a Howell, a Gour and Coopers ax, 3 hand saw, a dogg, an oxcart & wheels 2 yokes & cleaves & pin, a large Chain (at **JOHN FRINK**, 2 whip saws, a frying pan, a Gun, 6 or 7 bushels Salt, a Smoothing iron, 3 Spades).

THIS indenture made this 6th day of February in the year of our Lord one thousand seven hundred and fifty one Between **NATHAN FRINK** of Prince Georges Parish Craven County in South Carolina Planter of the one part & **WILLIAM GAUS** of the said Parish County and province innkeeper of the other part Witnesseth that for and in Consideration of the sum of three hundred pounds Current money of South Carolina to him the said **NATHAN FRINK** in hand paid at or before the Ensealing and Delivery of this present Deed the Receipt whereof the said **NATHAN FRINK** doth hereby Acknowledge & doth hereby acquit & Discharge the said **WILLIAM GAUS** his heirs &ca forever by these presents hath Granted Bargained sold Alienated Released Confirmed and Conveyed end by these presents doth grant bargain Alien Release Confirm and Convey unto the said **WILLIAM GAUS** his heirs or Assigns all that piece parcel or tract of Land Situate Lying and being in the County and province aforesaid Containing four hundred Acres butting & bounding to the North westward on Wacomaw River to the Southwestward on **FULTON**'s Land to the southeastward on the said **FULTON**'s Land & to the Northeastward on Mr. **MORRAL**'s Land partly & partly on Vacant Land as is more particularly Described by a plot and Grant thereof hereunto annexed doth appear and the Reversion Reversion & Reversions Remainder & Remainders yearly & other rents issue & profits thereof and of every part & parcel thereof To have & to hold the said piece or parcel of Land & other the premises above mentioned & intended to be hereby mentioned granted sold ratified & Confirmed and every part & parcel thereof with their & every of their appurtenances unto the said **WILLIAM GAUS** his heirs & Assigns forever to the only proper use & behoof of him the said **WILLIAM GAUS** and his assigns forever more & the said **NATHAN FRINK** doth for himself his heirs, executors, administrators and assigns Covenant promise Grant to & with the said **WILLIAM GAUS** that he the said **NATHAN FRINK** shall & will warrant & Defend forever the said Land & premises above mentioned unto the said **WILLIAM GAUS** his heirs & Assigns against all other Gifts Grants. Bargains, sales, Joyntures, Dowers, Judgments Executions Claims & Demands whatsoever Excepting nevertheless the Quit rents hereafter due to his Majesty & Successors the said **NATHAN FRINK**, putting the said **WILLIAM GAUS** in Quiet & peaceable possession of the Masion House & of the Land by Delivery of twig & turf.
