Know ye that we have granted unto **JAMES WILSON** fifty acres of land in our county of Mecklenburg on the waters of McCaulpens [McAlpine] Creek including his own improvement.

Beginning at a black oak, **ROBERT PARK**'s corner and runs with his line south eighty four west one hundred and eighty six poles to a hickory on said line; thence north thirty one east one hundred and eight poles to a black oak; thence south thirty three east sixteen poles to a black oak, **ALEXANDER MCGINTY**'s corner; thence with his line east seventy three poles to a black oak, said **MCGINTY**'s corner; thence with his other line south sixty five east eighteen poles to a stake on said line; thence south eighty seven west twenty poles to a stooping black jack said **MCGINTY**'s corner of another survey; thence with his line south twenty west thirty two poles to a black oak, said **MCGINTY**'s other corner; thence with his line to the beginning.

To hold to the said **JAMES WILSON**, his heirs and assigns forever.

To the surveyor of said county Greeting.

You are hereby required as soon as may be to lay off and survey for **JAMES WILSONS** a tract or parcel of land containing 100 acres laying and being in the county aforesaid on the head waters of McCalpans [McAlpines] Creek, joins **JOHN HILL**'s old place, **JOSEPH PARK**, **ALEXANDER MCGINTY** Senr. including vacant land in said bound entered may 30th 1793.

Observing the directions of an act of assembly in such case made and provided for running of lands, two just and fair plans of such survey with a proper certificate annexed to each, you are to transmit with this warrant to the secretaries office without delay.
