Know ye that we have granted unto **MATTHEW BRIAN** twelve acres of land in Mecklenburg County on the waters of Sugar Creek.

Beginning at a hickory **ZENAS ALEXANDER**'s corner and runs north forty one east twelve two poles to a pine on **DAVID HEANES** line, thence with said line south thirty six east seventy six poles to a gum on the creek bank thence with the meanders of the creek south eighty west twenty two poles to a hickory on **ZENAS ALEXANDER**'s corner thence with said **ALEXANDER**'s line to the beginning.

Entered the 6th of January 1797. To hold to the said **MATTHEW BRIAN** his heirs and assigns forever. Dated 22nd of November 1800.

JOAB ALEXANDER's office of claims for land entered in Mecklenburg County.

To the surveyor of said county, greetings.

You are hereby required to lay off and survey for **MATTHEW BRIAN** a head of lands in said county containing 30 acres on the waters of Sugar Creek joining the lands of **WILLIAM REED**, deceased, and **DAVID HAYNES**, **WILLIAM LEES** and his own lines entered January 6th 1797.

Observing the directions of an act of the assembly in such cases made & provided for running of lands. Two just & fair plans of such survey with a proper certificate annexed to each. You are to transmit with this warrant to the secretary's office without delay.

Given under my hand this 24th day of April Anno Dom 1799.
