JOAB ALEXANDER, entry officer of claims for lands entered in Mecklenburg County.

To the surveyor of said County, Greeting.

You are hereby required as soon as the law directs to lay off & survey for **SAMUEL ALEXANDER** a tract or parcel of land in said county containing 100 acres on the waters of McMichael's creek joining the lines of **JOHN KIRKPATRICK, ALLEN REED, CHRISTY ERVINS** lands, **JAMES LEES, THOMAS RUSSE [RUSSELL]** and **WILLIAM MARCHANT**. Entered July 13th, 1779.

Observing the directions of an act of assembly made & provided for the running of lands two just and fair plans of such survey with this certificate annexed to the secretary's office without delay.

Know ye that we have granted unto **SAMUEL ALEXANDER** ninety one acres of land in Mecklenburg County on the waters of McMichael's Creek.
