To the surveyor of said county, Greeting:

You are hereby required, as soon as may be, to lay off and survey for **SAMUEL ALEXANDER** a tract or parcel of land in said county containing 50 acres lying on the waters of Shugar [Shugaw, Sugar] Creek joining **THOMAS KIRKPATRICK, JAMES YANDLE** and **ALLEN REED** entered June 24th 1799.

Observing the directions of an act of assembly in such case made and provided for running of lands two just and fair plans of such survey with a proper certificate and annexed to each you are to transmit with this warrant to the secretary's office without delay given under my hand at the office the 3rd day of April 1800.

JOAB ALEXANDER, offices of claims for lands entered in Mecklenburg County.

To the surveyor of said County, Greeting.

You are hereby required as soon as the law directs to lay off & survey for **SAMUEL ALEXANDER** a tract of land in said county containing 100 acres on the waters of McMichael's creek joins on the north of place he lives in, on the South East side of the land he bought of **THOMAS POLK**, joins **ROBERT MOTHERAL's**, **MATTHEW BRIAN** and **JAMES YANDLE** on the south, thence to **JOHN CLARK's** on the south east on the North of Cooks on the south west of **CHRISTY [CHRISTOPHER] IRWIN's**.

Observing the directions of an act of assembly made & provided for the running of lands two just and fair plans of such survey with this warrant to the secretary's office without delay.

Given under my hand this 24th of June, A.D. 1799.

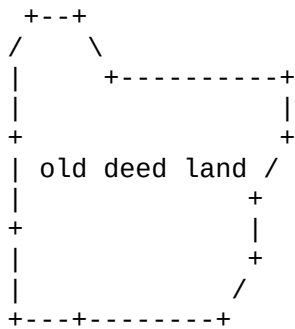

Surveyed for **SAMUEL ALEXANDER** one hundred and fifty Acres of land on the waters of McMichael's Creek lying round his brother's, **ARCHIBALD ALEXANDER**'s plantation know by the name of **MOTHERAL**'s old place.

Beginning at a Dogwood on the bank of the Creek on **MOTHERAL**'s line & runs south fifty four west one hundred and four poles to a pile of stones; North eighty three west forty six poles to a Pine; thence north sixty poles to a Black Oak; thence north ten east forty poles to a Hickory; thence north thirty west one hundred and fifty two poles to a Black Oak stooping with the dividing line; north sixty east forty eight poles to a Black Jack; thence south seventy east one hundred poles to a stake; thence north forty two east sixty poles to a Post Oak; thence south seventy seven east with **MARCHANT**'s corner; thence south forty seven east thirty poles to a Hickory; thence south twenty four west thirty four poles to a Post Oak, **MOTHERAL**'s second corner; thence to the beginning.

Know ye, that we, have granted unto **SAMUEL ALEXANDER** one hundred and fifty acres of land in Mecklenburg County on the waters of [McMichael's] McMikel's Creek lying round his brother **ARCHIBALD ALEXANDER's** plantation [MOTHARAL] **MOTHERAL's** old place.

Beginning at a Dogwood on the bank of the Creek, on [MOATHERAL's] **MOTHERAL's** line, & runs south fifty four west one hundred and four poles to a pile of stones; North eighty three west forty six poles to a Pine; thence north sixty poles to a Black Oak; thence north ten east forty poles to a Hickory; thence north thirty west one hundred and fifty two poles to a Black Oak stooping with the dividing line; north sixty east forty eight poles to a Black Jack; thence south seventy east one hundred poles to a stake; thence north forty two east sixty poles to a Post Oak; thence south seventy seven east with **MARCHANT's** corner; thence south forty seven east thirty poles to a Hickory; thence south twenty four west thirty four poles to a Post Oak, **MOTHERAL's** second corner; thence to the beginning.

No. 3281 entered 18th May 1795.

No. 46 entered 24th June 1799.

To hold unto the said **SAMUEL ALEXANDER**, his heirs and assigns forever.
