

**Probate, NC, Johnston, JAMES STALLINGS 1826**

In obedience to an order of the county court issued the 29th of December 1825 we the underside undersigned having been duly summoned and sworn have laid off to **ULRICA STALLINGS**, widow of **JAMES STALLINGS** deceased her dower in the lands belonging to the deceased in the following manner as the above plan will represent.

Beginning at a Red Oak **MORDECAI**'s line on Little Creek runs her line W 14 poles to a large red oak; thence cost crossing the Creek N 163 poles to a pine her Corner; thence her Line W 128 poles to a maple on the run of the north prong of Little Creek; thence down the meanders of said prong to the w prong; thence up the meanders of said prong to a white oak **JOHN TURNER**'s Corner on a branch; thence up the meanders of the branch to a pine his corner; thence his Line S 50 W 34 poles to a Black Jack; thence with **BEDDINGFIELD** line E 76 polls to a stake; thence S 19 poles to a stake then E 286 poles to a pine in the Rock Branch; thence down the meanders of said Branch to Little Creek; thence up the meanders of the creek to the beginning.

Containing three hundred and thirty eight acres.

In obedience to an order of the worshipful chard County Court of Johnston to us to divide and allot off to **ULRICA STALLINGS**, widow of **JAMES STALLINGS**, deceased, now **ULRICA JONES**, one-fifth part of the negroes belonging to the estate of the said **JAMES STALLINGS**, report that we have proceeded so to do and find fourteen negroes which we have valued to three thousand and fifteen dollars, which gives to each share pay one-fifth the sum of six hundred and three dollars and have allotted to said **ULRICA JONES** the following negroes, to wit: DANIEL, TILSY JR. and FURY, which we valued to six hundred and twenty five dollars which exceeds her part twenty two dollars, which some she is to pay the other heirs to wit: **ELIZABETH, ISAAC, JAMES, and ULRICA STALLINGS**, children of the said **JAMES STALLINGS**, deceased.

There is also one other small negro boy, LUCAS, about three years old which appears at this time to be an idiot, which boy we have not taken into the division at all, but surely to be disposed of at some future period and an equal expense to all the five claimants.

The other negroes after allotting to the said **ULRICA**, her part, we have left in common amongst the four children of the said deceased which is respectfully submitted March 20th 1832.

In Obedience of an order to the worshipful justices of the aforesaid county court we the undersigned commissioners having been appointed by their worships to allot to **BETSEY DURHAM**, wife of **SAMUEL DURHAM**, her share of the lands of her father, the late **JAMES STALLINGS**, deceased.

We allot to the said **BETSEY DURHAM** two hundred and sixty acres on the S side of Little Creek founded as follows:

Beginning at a Pine in **BEDDINGFIELD**'s branch, **JOHN TURNER**'s corner; thence with his line S 50 W 34 poles to a Black Jack. said **TURNER**'s corner; thence with **BEDDINGFIELD**'s line E 76 polls to a stake, his corner; thence with his other line S 75 poles to a Pine his and **WILLIAM JONES**'s corner; thence with **JONES**' line E 160 poles to a Hickory his Corner; thence N 126 poles to a Pine stump; thence E 65 polls to a run of Little Creek a persimmon tree; thence up the meanders of said Creek to the mouth of **BEDDINGFIELD**'s Branch; thence up the meanders of said Branch to the beginning.

The said share allotted to **BETSEY DURHAM** in to receive \$65 in consideration of the tower being upon it all of which is respectfully submitted this February 22nd 1837.

Pursuant to an order of the Court scratch County Court of Johnston issued at November, 1841 to the undersigned directed appointing them pay commission to divide the negroes belonging to **ISAAC W. STALLINGS, JAMES.B. STALLINGS,** and **ULRICA STALLINGS,** heirs of **JAMES STALLINGS** ,deceased.

We have discharge that duty and beg leave to report that we have set apart and divided as:

Lot No. 1 to **ULRICA STALLINGS** the following negroes to wit: SIMON, VILET, HENRY, JACKSON, MARIAH, and ELYVA valued at two thousand and seventy five dollars.

To **JAMES B. STALLINGS** as Lot No. 2 BRANCIL, TILEY, JOHN, WINNA, and CALEB valued at two thousand dollars.

To **ISAAC W. STALLINGS** as Lot No. 3 ISHAM, VINEY, ELMISA, HARRIS, and LUCY valued at two thousand dollars.

In consideration of any quality in the valuation of lots:

Lot No. 1, drawn by **ULRICA STALLINGS** pays to Lot No. 2, drawn by **JAMES B. STALLINGS,** and Lot No. 3, drawn by **ISAAC W. STALLINGS,** in money in the sum of \$25 furthermore.

Lot No. 1, drawn by **ULRICA STALLINGS,** and Lot No. 2, drawn by **JAMES B. STALLINGS,** each pays in money to Lot No. 3, drawn by **ISAAC W. STALLINGS,** the sum of one hundred dollars, in consideration of him, the said **ISAAC W. STALLINGS,** having taken and become the sole owner, maintainer, and supporter of two old, decrepit negroes ISAM & VILET, formerly the property of said estate during their natural lifetimes.

All of which is respectfully submitted given under our hand and seal January 7th 1842.

Pursuant to an order of the worshipful County Court of Johnson, issued at November term 1841, to the undersigned, directed, appointing them commissions to review and divide the lands belonging to **ISAAC W. STALLINGS, JAMES.B. STALLINGS** and **ULRICA STALLINGS**, heirs of **JAMES STALLINGS**, deceased.

We have discharge that duty and beg leave to report that we have set apart and divided out of the aforesaid lands as:

Lot No. 1, containing two hundred and sixty acres, to **ULRICA STALLINGS** valued at \$390 found it as follows to wit:

Beginning at a Sour wood on the west side of Little Creek; run thence W 208 poles to a stake; thence S 137 poles to a small Pine; thence S 80 degrees E 82 poles to a Pine in the Rocky Branch; thence S forty poles to a white oak; thence E 140 poles to a Pine; thence N 79 polls to a Red Oak; thence W 44 poles to a stake; thence N 20 poles to a stake; thence E 89 polls to said Creek; thence up the meanderings of said Creek to the beginning.

And pays to Lot No. 3 the sum of \$32.

Lot No. 2, drawn by **ISAAC W. STALLINGS** containing two hundred and sixty acres valued at \$390 bounded as follows to wit:

Beginning at a Sour wood on the Bank side of said Creek the beginning corner of Lot No. 1, runs W 208 poles to a stake; thence N 238 poles to a light wood stump; thence E 86 polls to the Run of said Creek; thence down the meanderings of said Creek to the beginning.

And pays to Lot No 3 the sum of \$32.

Lot No. 3, drawn by **JAMES B. STALLINGS**, containing two hundred and sixty Acres valued at \$295 bounded as follows to wit:

Beginning on the Bank side of said Creek; thence E 12 poles to a Red Oak; thence N 163 poles to a Pine; thence W 323 poles to a Pine; thence S 27 poles to a Pine; thence W 40 poles to a Sweet Gum in other prong of the creek; thence down the creek 27 poles; thence S 10 poles to a Red Oak; thence N 70 degrees E 23 poles to the said Creek; thence down the meanderings of said Creek to the beginning.

And receives from Lot No. 1 & 2 each the sum of \$32.
