The petition of **A. SPRINGS**, guardian for **JOSEPH GILLESPIE; ARCHIBALD ROBINSON; C. H. ROBINSON**, and his own right has guardian of **DORCAS ALEXANDER; CYNTHIA ROBINSON; JOHN KNOX** and his wife; hereby show to your worships that they are tenants in common of a tract of land descended to them from their ancestor **ROBERT ROBINSON** containing about two hundred and fifty acres, known as the **ROBINSON** place, adjoining the lands of **DAVIS R. HENDERSON, NANCY MCLURE, JAMES P. ANDERSON**, and **ARCHIBALD ROBINSON**. Your petitioners state that they are the only heirs at law of **ROBERT ROBINSON**, and that the land can, without detriment, be divided among them, to win, an share; **A. SPRINGS** guardian for **JOSEPH GILLESPIE**; and to **ARCHIBALD ROBINSON**, in his own right; and to **C. H. We, the undersigned commissioners, viz: **JAMES A. TODD; WILLIAM GRIBBLE; ADDISON FRAZIER;** and **BATT IRWIN;** being appointed by Court to divide and make partition between and among **ARCHIBALD ROBINSON, C. H. ROBINSON, CYNTHIA ROBINSON,** the heirs of **ELIZABETH ALEXANDER,** and the heirs of **MARY KNOX,** heirs of law **ROBERT ROBINSON** deceased whereupon we have made and do make the following appropriations, viz:

THE LOT NO. 1 is assigned and appropriated to The Heirs of **ELIZABETH ALEXANDER** bounded as follows, viz:

Beginning at an Ash on the branch on David Henderson's line and runs S 22 E 65 poles to a small Persimmon on **A. SAMPLE's** line; thence with said line N 57 E 111 poles crosses the creek at a small Black Oak, David Henderson's corner; thence with "seven" of **P. HENDERSON's** line N 30 W 57 poles crossing a branch to a White Oak; thence S 9 W 2 poles to a White Oak stump; thence S 62 W 37 poles crossing the creek to a branch on the side of a hill; thence N 27 W 23 poles to a White Oak by the meadow; thence S 52 W 35 poles to a large Poplar; thence S 73 W 15 poles to a Spanish Oak; thence S 38 E 6 poles to the beginning.

Containing thirty six acres (N. B. from the said Oak by the meadow the various courses of the branch is the line to the Ash on the branch) valued at two hundred and fifty dollars..

THE LOT NO. 2 his assigned and appropriated to **C. H. ROBINSON** bounded as follows, viz:

Beginning at a large Spanish Oak, **JAMES P. HENDERSON's** corner, and runs with the said the **HENDERSON's** line S 2 E 103 poles to a stake by the fence, **ALEXANDER MCLURE's** corner; thence with two of his lines N 80 W 72 poles to a stake on the Great Road; thence with the Great Road N 15 W 102 poles to a stake; thence N to W 15 poles to a large Black Oak on the side of Great Road; thence N 80 E 34 poles to a White Oak then S 76 E 61 poles crossing a branch to the beginning.

Contains sixty two acres valued at two hundred and ninety eight dollars.

THE LOT NO. 3 is assigned and appropriated to **ARCHIBALD ROBINSON** bounded as follows, viz:

Beginning at a Post Oak formerly a Black Oak at **HENDERSON's** corner and runs with **HENDERSON's** Line N 11 W 66 poles to a stake, the corner of another track belonging to **D. A. ROBINSON**; thence with his line N 79 W 116 poles crossing the Great Road to a White Oak by the old Red Oak stump **MARQUEE BARNETT's** corner; thence with the **BARNETT's** line S 1 E 94 poles to a Hickory on **BARNETT's** line; thence with a line of No. 4, N 87 E 120 poles crossing the great road to the beginning.

Containing fifty two acres valued at two hundred and fifty eight dollars.

THE LOT NO. 4 is assigned and appropriated to **CYNTHIA ROBINSON**, bounded as follows, viz:

Beginning at a post oak **ARCHIBALD ROBINSON's** corner and runs with line S 87 W 120 poles crossing the Great Road to a hickory on Marquis **BARNETT's** Line; thence S 1 E 100 poles to a Red Oak, **MCLURE's** corner; thence with **MCLURE's** line S 86 E 90 poles to a stake in the Gread Road; thence with the Great Road N 2 W 15 poles to a large Black Oak on the side of Gread Road, thence N 15 E 110 poles to the beginning.

Contains seventy one acres valued at two hundred and two dollars.

THE LOT NO. 5 is assigned and appropriated to the heirs of **MARY KNOX**, deceased, bounded as follows, viz:

Beginning at a Post Oak **ARCHIBALD ROBINSON's** corner and runs with his line S 15 W 110 poles to a Black Oak on the side of the Great Road, **C. H. ROBINSON** corner; thence with two of the said Robinson's lines N 80 E 34 poles to a White Oak; thence S 76 E 61 poles crossing a branch to a large Spanish Oak, **JAMES P. HENDERSON's** corner; thence N 89 E 57 poles to a Black Oak, **A. SAMPLES** corner; thence with **SAMPLES** line N 57 E 52 poles to a small Persimmon & stake on **SAMPLE's** line; thence N 22 W 65 poles to an Ash on the bank of the branch; thence the various courses of said branch S 38 W 12 poles to a Spanish Oak; thence N 80 W 7 poles to a Hickory; thence S 42 W 20 poles to a Spanish Oak; thence N 68 W 120 poles crossing the branch to the beginning.
