Do command you that by good and lawful men of your bailiwick you cause it to be made known to **SOLOMON PACE** and **WILLIAM BELL**, executors of the last will and testament of the said **THOMAS BRYAN**, deceased, that they be and appear at our next Inferior Court of Pleas and Quarter Sessions to be held for Northampton at the court house in Northampton County on the first Monday in June next to shew cause, if any they hath knoweth why the said suit should not be carried out by the said **SELBY TAYLOR** against them, the said **SOLOMON PACE & WILLIAM BELL** as executors of the said **THOMAS BRYAN**, deceased.

And have you then & there the names of those persons by whom you shall so cause it to be made known to the said **SOLOMON PACE** and **WILLIAM BELL**, together with this writ.
