To which payment well and truly be made, we bind ourselves, and every of us, our and every every of our heirs, executors and administrators for the whole, and in the whole, jointly and severally, firmly by these presents.

Sealed with our seals and dated the 30th day of October in the year of Our Lord 1848.

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH that if the above bound **JOHN ROBINSON** administrator of the goods and chattels and credits of **JAMES ROBINSON** deceased to make a true and perfect inventory of all and singular the goods chattels and credits of the deceased which have or shall come to the hands possession or knowledge of the said **JOHN ROBINSON** or into the hands or possession of any other person or persons for him and the same so made, do exhibit into the said Court of ordinary, when he shall be there in two required, and such goods, chattels and credits do well and truly administer according to law, and to make it just true account of his acting and doings there in when required by the said court and all the rest of the said goods chattels and credits which will be found remaining upon the account of the said Administration, the same being first allowed by the said Court, shall deliver and pay unto such persons respectively as are entitled to the Same by law, and if it should be here after appear that any last will and testament was made by the said deceased, and the same be proved in court, the then and then the executor is obtain a certificate of the probate thereof, and the said **JOHN ROBINSON** do in such case, if required, render and deliver up the said letters of administration, then this obligation to be void or else to remain in full force.
