The condition of the above obligation as such, that if the above bound **JAMES BUCKHANNAN & WILLIAM BUCKHANNAN** administrator of the goods, chattels and credits of **JAMES BUCKHANNAN** deceased, do make a true and perfect inventory of all and singular the goods, chattels and credits of the said deceased, which have or shall come to the hands, possession, or knowledge of the said administrator or into the hands or possession of any other person or persons for him and the same so made, do exhibit into this court of ordinary for **YORK**, when he shall be there until required, and such Goods, chattels, and credits, do well and truly administer according to law, and do make a just and true account of his acting and doings, when by law required; and further do well and truly pay and deliver all the Legacies contained and specified in the said Will as far as the said goods, chattels, and credits, will extend, and the law require then this obligation to be void, or else to remain in full force.
