In the name of God Amen.

I **ROBERT BRYANT** of the town of New Castle, Merchants, being sick and weak of body but of good and perfect memory and calling to remembrance the certainty of death and the uncertainty of the time they're of, do make this my last will and testament, revoking hereby all others whatsoever find me heretofore made in word or writing.

FIRST I do give my soul to God the Creator and maker of all, and my body to the Earth to be decently buried, and as to my worldly state where with it has pleased God to bless me, I give and disposed the same as followeth:

FIRST I give and bequeath unto **JOHN CANN** who married my daughter **MARY [BRYANT]** all the debt he owes me as money paid, goods sold him and other expenses.

AND all the rest of my estate, I give and bequeath unto my son **ROBERT [BRYANT]**, daughter **ANN [BRYANT]**, and **MARGARET HEATH**, equally to be divided between them and in case my son **ROBERT** happens to die before he come to age I give his part to my daughter **ANN** and **MARY** equally between them.

AND of this my last will and testament I make my son **ROBERT**, daughter **ANN**, and **MARGARET HEATH** joint executors and to nominate and desire my friend **RICHARD HALLIWELL**, overseer, in behalf of my son **ROBERT**.

In witness whereof I have hereunto set my hand and seal this second day of September 1701.
