

**Will, DE, Sussex, SARAH MANLOVE, 1732**

In the name of God Amen.

This 27th day of January in the year of Our Lord 1732, I, **SARAH [SPENCER] MANLOVE**, of the county of Sussex on Delaware Bay being sick and weak in body but of sound and perfect mind and memory, thanks to almighty God for the same, do hereby make my last will and testament in Manner and form following:

IMPRIMIS I give and bequeath unto my well-beloved brother **HENRY SPENCER** my Plantation in the county above said with all the land belonging to the same and all other the appurtenances belonging to the same to be held and enjoyed by him, his heirs and assigns forever.

ITEM I give unto **NOTTINGHAM JACOBS**, a young cow and calf and £4 to be paid out of my personal estate to assist toward paying for his schooling.

ITEM I give unto my sister **HANNAH SPENCER** all my clothes and all the residue of my creatures and £10 in money to be paid out two of my personal estate and delivered to her by my executor when she arrives to the age of 16 years.

ITEMS I give unto my two cousins, to wit: **MARY MANLOVE** and **ELIZABETH MANLOVE**, £3 each to be paid by my executors.

AND I make and depute my said brother, **HENRY SPENCER**, my executor of this my last will and testament unto whom I give and bequeath all the remainder of my estate utterly revoking and disannulling all former wills and bequests whatsoever by me heretofore made confirming this and no other to be my last will and testament.

In testimony whereof I have hereunto put my hand and affixed my seal the day and you're above written.
