Sealed with our seals, and dated this 5th day of February 1802.

The condition of the above obligation is such, that if see above bounden **BRYANT KITTRELL** administrator of all and singular the goods and chattels, rights and credits of **JONATHAN KITTRELL**, deceased, do make or cause to be made, a true and perfect inventory of all and singular the goods and chattels, rights and credits of the deceased, which have or shall come to the hands, knowledge or possession of the said **BRYANT KITTRELL** or into the hands or possession of any person or persons for **BRYANT KITTRELL** and the same so made, do exhibit or cause to be exhibited, in the secretary's office, and one attested copy thereof to the county court where orders for administration passed, within 90 days after the date of these presents; and the same goods, chattels, and credits, and all other goods, chattels, and credits of the deceased, at the time of his death, or which at any time Hereafter shall come into the hands or possession of the said **BRYANT KITTRELL** or into the hands or possession of any other person or persons for **BRYANT KITTRELL** do well and truly administer according to law: and further to make or cause to be made, a true and just account of his said Administration, with do time after the date of these presents, and all the rest and residue of the said goods, chattels and credits, which shall be found remaining upon the said administrators account (the same being first examined and Allowed by the governor and council, Superior or County Court) shall deliver and pay on to such person or persons respectively, as the same shall become do, pursuant to the true intent and meaning of the act in that case made and provided.
