HENRY** one of the justices assigned to keep the peace in and for the said District **JOHN STEWARD, HENRY WHISENANT** and **JESSE PONDER** being three of the appraisers appointed to appraise the goods and chattels of **WILLIAM MULLINAX** late of York District deceased, who being duly sworn, made oath, that they would make a just and true appraisement of all and singular, the goods and chattels of the said **WILLIAM MULLINAX** deceased, as shall be produced by **ISAAC MULLINAX**, administrator of the estate of the said deceased, and that they would return the same, certified under their hands, unto the said **ISAAC MULLINAX** on or before the 25th day of December next.

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, that if the above bound **ISAAC MULLINAX** administrator of the goods, chattels and credits of **WILLIAM MULLINAX** deceased with the will annexed do make a true and perfect inventory of all and singular the goods, chattels and credits of the deceased, which have or shall come to the hands, possession or knowledge of the said **ISAAC MULLINAX** or into the hands or possession of other person or persons for him and the same so made, do exhibit into the said Court of ordinary, when he shall be there on to required, and such goods, chattels and credits to well and truly administer according to law, and do make a just and true account of his acting and doings there in when required by the said Court, and all the rest of the said Goods, chattels and credits which shall be found remaining upon the account of the administration, the same being first allowed by the second court, shall deliver and pay on to such persons respectively as are entitled to the same by law, required and further do well and truly pay and deliver all the legacies contained & described in the last will as far as the land, good & chattles will extend & the law require, then this obligation to be void or else to remain in full force.
