I **MARY DUNKIN [DUNCAN]** being weak in body but of perfect mind and memory calling to mind the uncertainty of life and that it is appointed for all to die I do ordain and appoint this my last Will and Testament and make null and void all other wills heretofore made and I first commit my soul go God and my body to the Grave and all my lawful debts to be paid.

ITEM I give and bequeath to my Niece **ANN KIDD** all that tract of land on which I now live (which was willed to me by my beloved Husband **THOMAS DUNKIN [DUNCAN]** to dispose of at my pleasure) for her use her life time and after her death to her heirs forever.

ITEM I give and bequeath to my said Niece **ANN KIDD** all my Stock of every description and all my household goods of all kinds and notes or bonds and all property to me belonging whatsoever.

AND I do hereby appoint **CHARLES BROWNFIELD [BRUMFIELD]**, **HENRY KERR**, and **GEORGE DAVIS** executors of this my last will and Testament.
