 en hundred and ninety three and of the sovereignty  
 and Independence of the United States of America  
 the eighth between William Bryant of the

County of Wilkes and State aforesaid of the one part &  
 Micajah Williamson son of the County of Wilkes and  
 said State of the other part. Witness that he the said  
 William Bryant for and consideration of the sum of one  
 hundred Pounds sterling to him in hand paid by the said  
 Micajah Williamson the receipt whereof he the said William  
 Bryant doth hereby acknowledge hath granted bargain  
 sold aliened and confirmed and by these  
 presents doth grant bargain sell alien and con-  
 firm unto the said Micajah Williamson his heirs  
 and assigns forever all that tract or parcel of land  
 containing one Thousand Acres the boundaries &  
 Markes to be more fully appear by reference to a plat  
 annexed to the Original grant for said tract of  
 land granted to the said William Bryant twenty  
 sixth day of October in the Year of our Lord one  
 Thousand seven hundred and ninety three which  
 said tract of land is known by the number of Acres  
 in a General Draft Eighty two Thousand Acres  
 of land all of which lying and being in the County  
 of Franklin on the West of the Apalachian River &  
 in the Continental Reserve with all and singular  
 the premises and appertinances whatsoever to the  
 said tract of land belonging or in any manner  
 appertaining and the said William Bryant for  
 himself and his heirs against all and every Person  
 or Persons whatsoever claiming any right or title to  
 the said tract of land and premises together  
 with the appertinances to the same belonging in fe  
 simple to the said Micajah Williamson his  
 heirs and assigns will warrant and forever

Witnesseth that for and in consideration of the sum of three hundred Pounds sterling to him in hand paid by the said Micajah Williamson Senior the receipt whereof the said John Smith doth hereby acknowledge hath granted bargained sold aliened and confirmed and by these presents
