This Indenture made this 19th Day of April in the year of our Lord 1781 Between John Bryant of the County of Orange and State of North Carolina of the one part & Edward Price of the County and State aforesaid of the other part Witnesseth That the said John Bryant found in consideration of the sum of Twenty five Pound to him in hand paid at or Before the sealing and delivery hereof the receipt whereof he doth hereby Confess and acknowledge and thereof and every Part thereof do acquit exonerate and discharge the said Edward Price his heirs and assigns by these presents have granted, Bargained and sold, aliened, Released and confirmed & by these presents do grant, Bargain and sell, alien, Release and confirm unto the said Edward Price his heirs and assigns forever a certain tract or parcel of Land situate lying and being in the said County of Orange & on the waters of Sawhope and bounded as follows to wit, Beginning at a pine in his own line thence West 25 pole to a hickory and oak Bush, then North 15 1/2 poles to a Stake on Moss Hutchens line, then East along his line 20 pole to a Stake, then South 12, East 12 pole to a pine then South 22 East 10 pole to a maple, then South 10 West 20 pole to a maple then S^o 8 West 18 pole to a pine then South 86 pole to the Beginning containing 25 Acres 1/4 Be it more or less the reversion & reversions remainder & remainders Rents Issues and profits thereof also all the estate, Right Title property Claim and demand whatsoever as within Equity and in Law of him the said John Bryant and his heirs of in and to the said land and premises and of in and to every part and parcel thereof to have & to hold the said tract of Land and premises with their and every of their appurtenances unto the said Edward Price his heirs & assigns to the only proper use & behoof of him the said Edward Price his heirs and assigns forever and the sd^o J^{as} Bryant for himself his heirs do covenant grant to and with the said Edward Price his heirs and assigns that he the said John Bryant his heirs Executors administrators and assigns the said tract or parcel of Land and premises hereby Bargained & sold against him and his heirs and against every other person or persons (Claiming etc Claim by from or under them to the said Edward Price his heirs and assigns shall & will warrant and forever defend by these presents In witness whereof the said J^{as} Bryant hath hereunto set his hand and affixed his seal the day and Year first above written entered into before signed
